CPA[®]:18 – Global Distribution Announced for Fourth Quarter 2014

The Board of Directors of CPA[®]:18 – Global announced that the fourth quarter 2014 daily distribution rates will be:

- \$0.0016983 per share for Class A stock, which equates to an annualized rate of 6.25% on its initial public offering price of \$10.00 per share, and
- \$0.0014442 per share for Class C stock, which equates to an annualized rate of 5.68% on its initial public offering price of \$9.35 per share.

Fourth quarter 2014 distributions will be payable to stockholders of record as of the close of business on each calendar day during the quarter and will be paid in aggregate on or about January 15, 2015.
